The Department of Clinical Health Psychology in the Faculty of Medicine, University of Manitoba, in collaboration with the Winnipeg Regional Health Authority (WRHA) invites applications for two Contingent Geographic Full-Time Forensic Clinical Psychologists at the Assistant Professor level (positions # 1423 and # 1424), commencing June 1, 2013 or as soon as possible thereafter. The successful applicants will join a multi-disciplinary team providing a full range of forensic mental health assessments and treatment for forensic inpatients and outpatients. The position will be based at the Health Sciences Centre in Winnipeg.

Position Responsibilities:

- Forensic Psychological assessments as part of a Forensic Mental Health Team
- Psychological treatments for both forensic inpatients and outpatients.
- Psychological consultation to other health professionals.
- Clinical research and programme evaluation.
- Supervision of Psychology Residents in our CPA accredited Psychology Residency training programme
- Participation in teaching of medical students, residents and students in other health professions.

Qualifications:

- Doctoral degree (PhD or PsyD) in Clinical Psychology from a CPA accredited training programme, and completion of a CPA accredited Internship / Residency.
- Specialized education, training and experience in Forensic Psychology.
- Eligibility for registration as a Psychologist by the Psychological Association of Manitoba (the Clinical Health Psychology programme of the WRHA will provide the required pre-registration supervision for individuals at the C. Psych. Candidate level).
- Satisfactory results of pre-employment criminal records and child abuse registry checks.
- Education and experience in administration and interpretation of standard adult psychological tests and measures in a forensic context.
- Experience with evidence-based psychological treatments.
- Excellent interpersonal, communication, and inter-professional teamwork skills.
- Training, experience, and/or research background and interests in Aboriginal health issues would be an asset.
