



REHABILITATION NEUROPSYCHOLOGIST

The Department of Clinical Health Psychology in the College of Medicine, University of Manitoba, in collaboration with the Winnipeg Regional Health Authority (WRHA) invites applications for a Contingent Geographic Full-Time Rehabilitation Neuropsychologist (position # 17786), commencing October 1, 2014 or as soon as possible thereafter. Academic rank (Assistant / Associate Professor) and salary will be contingent upon qualifications and experience. The successful applicant will join a team of neuropsychologists providing assessment and consultation services to a variety of referral sources, including Neurosurgery, Neurology, Rehabilitation Medicine, and other clinical and rehabilitation programs and services within the hospital and community. The position will be based at the Health Sciences Centre, Winnipeg's largest teaching hospital.

Position Responsibilities:

- Neuropsychological assessment and evaluation
- Cognitive rehabilitation interventions and programs
- Psychological consultation to other health professionals and staff education
- Clinical research and publication
- Supervision of Psychology Residents in our CPA accredited Psychology Residency training program
- Teaching medical students, residents and students of other health professions

Qualifications:

- Doctoral degree (PhD or PsyD) in Clinical Psychology or Clinical Neuropsychology from a CPA accredited training program
- Completion of a CPA accredited Internship / Residency.
- Specialized education, training and experience in adult Rehabilitation Neuropsychology.
- Clinical experience in the areas of epilepsy, movement disorders, neurodegenerative conditions, neurosurgery, and / or brain injury

- Eligibility for registration as a Clinical Neuropsychologist by the Psychological Association of Manitoba (the Clinical Health Psychology program of the WRHA will provide the required pre-registration supervision for individuals at the C. Psych. Candidate level).
- Satisfactory results of pre-employment criminal records and child abuse registry checks.
- Education and experience in administration and interpretation of standard adult neuropsychological tests and measures
- Experience with evidence-based psychological rehabilitation and treatment interventions
- Excellent interpersonal, communication, and inter-professional teamwork skills.
- Training, experience, and/or research background and interests in Aboriginal health issues would be an asset.
