



## **International Experts Gather to Discuss Best Policy and Practice to Prevent Sexual Abuse and Manage Sexual Offenders**

**For Immediate Release – November 1, 2011 (Toronto)** – Over one thousand attendees will participate in the 30th Annual Research and Treatment Conference of the Association for the Treatment of Sexual Abusers (ATSA) being held November 2-5 at the Sheraton Centre Toronto. “Experts from around the world will discuss how to keep communities safe from sexual abuse, including best practices for preventing sexual re-offending.” reports Dr. Lawrence Ellerby, President of ATSA.

Dr. Mark Olver, Chair of the Criminal Justice Section of the Canadian Psychological Association adds, “the ATSA conference exemplifies the importance of comprehensive strategies for the assessment, treatment, and supervision of sex offenders to prevent and reduce sexual victimization and promote safer communities.”

Experts from a cross section of fields such as sexual abuse prevention, law enforcement, corrections, sex offender treatment and management, victim advocacy, and law will discuss the latest research and state-of-the-art clinical, management and public policy approaches and interventions to keep communities safer. Topics include assessment and treatment of sexually abusive behavior; Internet sex offending; pedophilia; and current and recommended public policy to prevent sex offender re-offence.

Canadian Psychological Association CEO, Dr. Karen Cohen, notes that “The ATSA conference is particularly timely as the Canadian government works to pass the *Protecting Children from Sexual Predators Act* of the proposed and debated *Safe Streets and Communities Act* (Bill C-10)”. CPA joins ATSA in drawing public attention to the following research findings:

- The prevention and reduction of sexual offending is a key contributor to public safety;
- Addressing this issue leads to less crime and fewer victims;
- Evidence-based treatment with medium and high risk offenders provides the most cost-effective and successful strategy to preventing and reducing sexual offending; and
- Sanctions such as mandatory minimums imprisonment sentences and/or jail or prison time without available effective treatment does not reduce recidivism and may increase the risk of reoffending when the offender returns to the community.
