

In recent years, various Statistics Canada surveys that provided information on psychology graduates have been discontinued. In response, the CPA has developed a comprehensive ongoing survey of psychology master's

and doctorate graduates, be they registered psychologists or not. With time, our goal is to obtain a complete demographic profile of all individuals with a graduate degree in psychology working across the multiple domains of psychology in Canada. Findings will provide valuable information to assist with the education, science, and practice of psychology.

In November and December, the CCR met with MP Saxton (PC, Parliamentary Secretary to the Minister of Finance), MP Hsu (Liberal Science Critic), MP

Stewart (NDP Science Critic), MP Vankesteren (PC, FINA Committee) to discuss its pre-budget submission.

In December, the CCR hosted its 3rd annual breakfast with the funders at the CPA Head Office. The breakfast was attended by

representatives from CIHR, NSERC, SSHRC, CFI and MITACS.

In the coming months, the CCR will develop a questionnaire as part of its election preparation activities.

Each of CPA's journals has special issues planned in the coming months. CP's issue will focus on positive psychology; CJEP's will focus on production effect in memory and CJBS's will focus on purpose and agency. ## Cancellation of the Long-Form Census

Over the last few years, Canada has experienced a loss in standardized data with the cancellation of the mandatory long-form census, the University and College Academic Staff System Survey (UCASS), and the Survey of Earned Doctorates (SED). The implications of these cancellations on surveillance and human resource planning are sig-

nificant.

With respect to the census, the CPA wrote a letter of support for Liberal Science and Technology Critic, MP Ted Hsu, who had developed a private member's bill to reinstate the long-form census. In addition, following a meeting with MP Hsu, we developed a survey – at his request – as a means of collecting data

from our membership on the impacts of the cancellation of the census. Although MP Hsu's bill was not passed, the CPA will continue to advocate for the need for a mandatory long-form census as part of its advocacy efforts for the next federal election.

## Science Advocacy and Integrity

In November, Dr. Lisa Votta-Bleeker gave a presentation on science advocacy to the Canadian Council of University Biology Chairs (CCUBC), and had a meeting on the same topic with the Executive Director of Evidence for Democracy .

In March, she met with a representative from the Department of National Defence regarding scientific integrity, specifically as relates to plagiarism (both verbatim and conceptual), falsification of data (by students and established researchers), authorship negotiations between students and supervisors (in light of no standardized rules governing authorship across institutions), and other forms of unethical conduct involving psychological research.

This issue has been brought forward to the Chairs of Scientific Affairs, Publications and Ethics to discuss options to address this. It has also been brought forward to the CCR, where member representatives indicated they were grappling with the issue as well.
