Dr. Bonnie Dobbs is the Associate Director of the Rehabilitation Research Centre at the University of Alberta, an Assistant Professor in the Faculty of Rehabilitation Medicine, an Adjunct Academic Assistant Professor in the Department of Family Medicine, and an Adjunct Professor in the Department of Psychology at the University of Alberta. She has published widely in the areas of medical conditions and driving, assessment procedures and the consequences of having to stop driving. Dr. Dobbs' research and research reviews have served as the foundation for guidelines for

physician assessment of medical fitness-to-drive for the National Highway Traffic Safety Administration (U.S) and the American Medical Association.

Dr. Allen Dobbs is a Professor Emeritus in the Psychology Department, a Professor in the Division of Neuroscience and an Adjunct Professor of Medicine at the University of Alberta. His research has centred on the assessment of drivers having a medical condition that can affect mental competence and has culminated in the research-based and validated driver assessment procedures of DriveABLE.
