## Advocacy: PDF Fellowships, Masters Funding



The CPA continues to liaise with NSERC regarding: 1) its decision to reduce the number of times an individual could apply for a post-doctoral fellowship from two to one; and 2) its decision to reduce its masters funding from two years to one.

We have discussed the issues with NSERC representatives and raised the issues in the CPA's submission to the Fundamental

Science Review in Canada.

Most recently, the CPA collaborated with the Canadian Society for Brain, Behaviour and Cognitive Science (CSBBCS) and sent letters regarding these matters to NSERC President, Dr. Mario Pinto.

We did receive a response from NSERC; although no changes are imminent to either policy, they will bring the PDF matter forward in their upcoming dis-

cussion with the other granting agencies in the context of looking at how the CGS program should evolve over time, and will revisit the Masters policy in the context of the increased number of awards they were able to give in the last few competitions.

The CPA will continue to advocate for changes on these matters and encourages the membership to do the same.



## International Congress of Applied Psychology 2018

Planning continues for the International Congress of Psychology (ICAP) 2018, which the CPA will host in Montreal, QC, from June 26—30, 2018.

The Scientific Program has solicited nominations for speakers for its State of the Art Lectures and Congress Keynotes. Invitations to present were also made to various Presidents of international associations with whom

## Canadian Consortium for Research (CCR)

Dr. Votta-Bleeker continues to serve as Chair of the CCR, in this role since May 2013

Recent activities of the CCR include: making a pre-budget submission as part of the 2017 pre-budget consultation; applauding the Government's reinstatement of the University and College Academic Staff System Survey (UCASS); attending the Canadian Science Policy Conference; and hosting the 5th annual

Breakfast with the Funders; representatives from SSHRC, NSERC, CFI and Mitacs attended the breakfast in January 2017 at the CPA's Head Office in Ottawa, Ontario.

## CPA Best Article Awards

Each year, the CPA gives awards for the best papers submitted in each of its journals from the previous year. Two of the awards are funded solely by the CPA, while one of the awards is co-sponsored by the CPA and the Canadian Society for Brain, Behaviour and Cognitive Science (CSBBCS). The awards for CP and CJBS are given at the CPA's national convention, while the award for CJEP is given at both the CPA's national convention and the CSBBCS' annual meeting; each award comes with a \$1,000.00 prize. For the first time, the articles of all award winners have been made open access.

## Psychological Science: Advocacy and Promotion

Additional activities undertaken by the Science Directorate and the CPA to advocate for and promote psychological science include:

### Panel on Non-Academic Career Path

On March 2, 2017, Dr. Lisa Votta-Bleeker, CPA's Deputy CEO and Science Director, was invited to be part of a Graduate Pro-Seminar Panel organized by the Chair of the Psychology Department at Carleton University in Ottawa. The panel focussed on the Non-Academic Career Path, with panelists showcasing the variety of non-academic positions that one can hold with a Ph.D. in psychology.

### Ambassador Program

On May 8<sup>th</sup>, 2017, the CPA will visit various universities and hospitals in Fredericton and Moncton as part of an organized Ambassador Visit. Two of the CPA's Executive Officers (Dr. Karen Cohen and Dr Votta-Bleeker) will participate in these visits alongside four of the CPA's Board of Directors (Dr. Jean Saint-Aubin, Dr. David Dozois, Dr. Patrick Bailie, Dr. David Bourgeois).

### Section Engagement

In December 2016, the Science Directorate funded a meeting with the Chair of the Students Section to explore ways in which the CPA and the Students Section could work together to better engage CPA student affiliates and attract more student affiliates. In October/16, CPA's Executive Officers also met with Executives of the Section for Educational and School Psychology to discuss the same; these meetings build on meetings that were first initiated in December 2015 as part of Dr. Kelloway's Presidency of the CPA.

### National Research Council – Review of Annual Performance Reports

In March 2017, Dr. Votta-Bleeker served as a reviewer for the Canadian National Committee Annual Performance Reports (CNC APRs) for which the National Research Council pays Canada's dues to scientific unions; she participated in the review of four CNC APRs.

### Knowledge Mobilization

The CPA continues to look at ways that we can support our members with knowledge mobilization, such as providing an outline of the role the CPA can play as a KM collaborator; providing best practices information on knowledge mobilization; and facilitating linkages to knowledge mobilization experts. Travis Sztainert, Psychology Professor at Carleton University, is in the final development states of an online course on KM as part of our CPD offerings.
